

MEETING MINUTES

The North Central Florida Healthcare Coalition held its in-person meeting on May 22, 2024, at 1:30. The meeting was held in-person in the Thomas Coward Auditorium at the Alachua County Health Department.

CALL TO ORDER

In the excused absence of the Chair, Matt Ferguson, Suzanne DeKay, the Secretary/Treasurer Chaired the meeting. Additionally, due to the Public Health discipline Board vacancy, Natalie McKellips (Health Officer for DOH-Gilchrist/Levy/Dixie, was willing to represent the discipline at the meeting.

The meeting was called to order by Secretary/Treasurer, Suzanne DeKay, with a validation of members, with the following Board members present. Quorum was met for voting.

Welcome & Introductions

Secretary/Treasurer, Suzanne DeKay, welcomed everyone to the meeting.

Approval of Minutes

The minutes from January 2024, February 2024, and March 2024 were provided to Board members via electronic mail and May Meeting Packet.

The Secretary/Treasurer called for a motion of approval. Ms. Butler moved approval; Mr. Long seconded; Motion carried.

FINANCIAL

Finance Report

Secretary/Treasurer, Suzanne DeKay, presented the finance report through April 2024.

The Secretary/Treasurer called for a motion of approval. Mr. Long moved approval; Ms. Butler seconded; Motion carried.

MANAGEMENT AND ADMINISTRATION

- Project Funding Update Staff report seven projects have been reimbursed and completed –
 Flagler County Emergency Management (FirstNet miniCRD), Baptist Health System (PAPRs),
 Baker County Emergency Management (Training Manikins for MCI Exercises), Baker County Fire
 Rescue Department (MCI Trailer Replenishment), Lake Butler Hospital (Decon/MCI Equipment),
 Dixie County Emergency Services (SimMan Training Manikin), and AdventHealth Palm Coast
 Parkway (Decon Equipment). The two remaining projects are still in the process of procurement
 due to delays in supply chain/shipping but remain on track to be completed by June.
- **EMAG Conference Recap** The EMAG Conference in Savannah, GA was a success with 23 members across the Alliance in attendance. Members report it was a great learning opportunity, with training ranging from cybersecurity, weather-related threats, and other valuable and pertinent topics to emergency management and healthcare.
- New Contract (FY24-29) Staff share they have not received the new contract yet but have heard from the State to expect level funding for the new contract. Once the contract is made available to HCC staff, there will be a strategic planning workshop with the Alliance Board's to review and discuss the five-year contract. Staff share there may be changes to project funding based on the new contract language, as future projects may have to be more regional in focus.
- New Website Demonstration HCC staff shared the new website is not available yet but did
 have a test site to demonstrate to meeting attendees. HCC staff welcomed any feedback and
 suggestions.
- MRSE Staff report the MRSE exercise held in Marion County on May 7th was a success, and
 there was information and learning opportunities to come from the exercise. Further, the
 information and lessons learned from the TTX was implemented one week later in Marion
 County as they had a real-world MCI, and the hospital and EMS partners utilized the techniques
 used during the MRSE to distribute patients across the local healthcare and transportation
 system.

• June & July Meeting Staff report the June meeting date for the Northeast Florida Healthcare Coalition falls on the Juneteenth holiday, and their meeting will be canceled. All Northeast HCC members will be invited to attend the virtual North Central HCC meeting on June 26 at 1:30 PM.

Additionally, the Northeast Florida Regional Council office is moving to a new location in July. Therefore, HCC staff and Board agree to cancel the July meeting during the move and will resume the meeting in August.

Board Nominations

MEMBER REPORTS AND OPEN DISCUSSION

Hospitals – Ms. Suzanne DeKay with UF Health Shands shared the hospital system is full. Shares to accommodate bed placement and EMS wait times, hospital representatives are meeting daily to place patients within the hospital. Shared that supply chain issues have become the new normal, and their system has acclimated. Their internal supply chain staff have developed effective methods to combat supply issues. Reported they are participating in the mass casualty exercise hosted at the UF stadium at the end of June. Additionally, UF Health is excited to use the Pulsara platform and are working to get local EMS agencies on board.

Mr. Jason Long added the rural EMS agencies and medical directors are looking forward to using the Pulsara system.

Mr. Mark Cromer with HCA Florida North Florida Hospital echoed Ms. DeKay's report. He added that the patients they are seeing are higher acuity, as well.

Emergency Management – Ms. Lola Butler shared on behalf of Mr. Ralph Smith from Gilchrist County Emergency Management that they were able to procure 2 EMS vehicles.

Ms. Francine Vincent from Alachua County Emergency Management shared they are conducting shelter manager and staff training in June. Shared the EOC is hosting two upcoming training courses and links to register can be found on the Alachua County Emergency Management Facebook page. Additionally, EM staff are conducting public outreach ahead of hurricane season.

Public Health -

Mr. Rel Perea shared on behalf of Mr. Shane Ross with DOH – Columbia/Hamilton, the efforts they are taking following lessons learned from the RDSTF/Statewide exercise in Region 2. This includes acquiring naloxone for EMS/fire agencies, law enforcement, and student resource officers within their region.

Mr. Long shared that at the Governor's Hurricane Conference the increased storm potential for this upcoming hurricane season.

EMS – Nothing to report.

Long-Term Care - Nothing to report.

At-Large Representatives – Mr. Rel Perea shared lessons learned from the recent storms and tornadoes in Region 2, and the subsequent damage. It was also brought to their attention the issue of senior living (55+) communities that are apartment style and are not subject to AHCA requirements. Therefore, these communities/buildings were not checked on and were without power. Such communities should be considered in planning, especially if there are electricity dependent residents and the complexities of evacuating a multi-story senior living community.

Mr. Scott Holowasko with Gainesville Regional Utilities added that the storms and tornado damage in Region 2, from a utilities perspective, was worse than the last few tropical storms.
