

MEETING MINUTES

The North Central Florida Healthcare Coalition held its virtual meeting on September 24, at 1:30. The meeting was held virtually via Zoom.

CALL TO ORDER

The meeting was called to order by the Chair, Matt Ferguson, with a validation of members, with the following Board members present. Quorum was met for voting.

Welcome & Introductions

Chair, Matt Ferguson, welcomed everyone to the meeting.

Approval of Minutes

The minutes from June 2025 were provided to Board members via electronic mail and September Meeting Packet.

The Chair called for a motion of approval. Mr. Mark Cromer moved approval; Mr. Ralph Smith seconded: Motion carried.

FINANCIAL

*Finance Report

Secretary/Treasurer, Lola Butler, presented the finance report for August 2025.

The Chair called for a motion of approval. Mr. Smith moved approval; Mr. Cromer seconded; Motion carried.

MANAGEMENT AND ADMINISTRATION

- **FY25-26 Update** Staff shared this year's contract amendment for level funding was fully executed in July. Most of the deliverables remain the same as last fiscal year with cybersecurity assessment, extended downtime assessment, supply chain assessment, and there is an addition with the recovery plan. Staff shared there are more than likely to be changes forthcoming from HHS, and those will be shared as they are received.
- Recap of August Alliance Board Meeting Staff shared the Alliance Board workshop was held in August at the NEFRC's office in Jacksonville with 24 attendees. During the workshop, there was a visioning and SWOT exercise conducted by NEFRC staff to garner where the Alliance is going. The final report will be shared with members in December. Staff also discussed with the Board members the budget for this fiscal year, and received guidance from the Board on how to focus funding if there was a 30% reduction. The Alliance Board moved the 30% reduction sum to projects.
- BOLDPlanning Update Staff reported the BOLDPlanning software license is good through March
 of 2026. Due to lack of engagement across the state, the Florida HCCs have decided to pull their
 funds from purchasing this annual license. More information to come for those members who
 have plans in the BOLD system, and next steps for acquiring the plans and agency/facility specific
 continuation of BOLD contracts.

BUSINESS

New Members

Twenty-one (21) new member requests were presented for membership.

The Chair called for a motion of approval. Mr. Smith moved approval; Ms. Vincent seconded; Motion carried.

HVA Review

Staff shared the regional HVA was shared with the September meeting packet. This year's updates to the HVA were cursory, with no changes to the regional hazards or level of risks. Staff asked for all feedback and mitigation strategy ideas to be shared with staff prior to Tuesday, September 30th.

Resources and Gaps Working Group

Staff shared the Regional Resources and Gaps working group will resume meeting this fiscal year to develop project ideas. From these meetings, staff will begin the project process (i.e., surveys, RFQs, etc.) in case the 30% reduction is reinstated.

VTTX Opportunities

Staff shared there are plans to provide 3 virtual tabletop exercise series, with two offerings each, this fiscal year. The topics will include extended downtime, supply chain, and tropical weather. Registration and flyers will be shared as they become available.

Shelter-In-Place Training & Exercise

Later this fall and in early winter there will be shelter-in-place training and subsequent exercise opportunities in conjunction with the LEPC. More information to come.

MEMBER REPORTS AND OPEN DISCUSSION

Hospitals – Mr. Mark Cromer with HCA Florida North Florida Hospital shared they are monitoring the political climate to see how they can prepare their facility. Their EM and safety teams have prepared plans to address and respond to events of violence, MCIs, and other cascading impacts.

Emergency Management – Mr. Ralph Smith with Gilchrist County Emergency Management shared they continue to prepare for storm season. Gilchrist EM conducted a Board of County Commission exercise with representatives from each county department earlier today and had surrounding counties participate as observers. Reports all participants found value in the exercise.

Public Health – Nothing to report.

EMS – Mr. Matt Ferguson with Dixie County Fire Rescue shared the supply chain issues continue to improve. The new issue is working through grant delays and impacts from audits conducted on funding sources. Additionally, they continue to monitor and prepare for storm season.

Long-Term Care – Nothing to report.

At-Large Representatives -

Ms. Francine Vincent with Alachua County EM shared they are updating their LMS plan and recently had their CEMP approved.



Operations Level Response to Radiological/Nuclear WMD is designed for public safety personnel and first responders who, in the course of their duties may participate in radiological/nuclear emergency response.

The course provides an introduction to operations in a radiological/nuclear environment during incidents involving radiological Weapons of Mass Destruction (WMD). The curriculum includes detailed information on the radiological and nuclear threats facing our Nation, fundamentals of radiation, an introduction to radiological detection and survey instruments, protective measures that may be employed by first responders, personal protective equipment and decontamination. As part of the training, Participants will engage in drills designed to enhance their ability to perform the basic tasks required to safely and effectively execute their duties in a radiological WMD response mission.


