*Approval of Minutes

The draft minutes from June 18, 2025, Board of Directors Meeting were provided as part of the meeting packet.

The Chair called for a motion. A motion was made to approve the draft minutes by Sonny Rodgers (Clay County). A second was made by Gavin Butler (St. Johns County). Motion carries.

FINANCIAL

*Budget Report

The finance report for August 2025 was presented by Annie Sieger.

The Chair called for a motion. A motion was made to approve the financial report by Gavin Butler (St. Johns County). A second was made by Jaffy Lee (Flagler County). Motion carries.

Management and Administration

FY25-26 Update

Staff shared this year's contract amendment for level funding was fully executed in July. Most of the deliverables remain the same as last fiscal year with cybersecurity assessment, extended downtime assessment, supply chain assessment, and there is an addition with the recovery plan. Staff shared there are more than likely to be changes forthcoming from HHS, and those will be shared as they are received.

Recap of August Alliance Board Meeting

Staff shared the Alliance Board workshop was held in August at the NEFRC's office in Jacksonville with 24 attendees. During the workshop, there was a visioning and SWOT exercise conducted by NEFRC staff to garner where the Alliance is going. The final report will be shared with members in December. Staff also discussed with the Board members the budget for this fiscal year, and received guidance from the Board on how to focus funding if there was a 30% reduction. The Alliance Board moved the 30% reduction sum to projects.

BOLDPlanning Update

Staff reported the BOLDPlanning software license is good through March of 2026. Due to lack of engagement across the state, the Florida HCCs have decided to pull their funds from purchasing this annual license. More information to come for those members who have plans in the BOLD system, and next steps for acquiring the plans and agency/facility specific continuation of BOLD contracts.

BUSINESS

*Approval of General Membership Requests

As required in the bylaws, the Board must approve all membership requests. There have been twenty-one (21) membership requests since the last meeting. The list was provided in the meeting packet.

The Chair called for a motion. A motion was made by Sonny Rodgers (Clay County) to approve the new members. A second was made by Susan Chapman (Home Health). Motion carries.

HVA Review

Staff shared the regional HVA was shared with the September meeting packet. This year's updates to the HVA were cursory, with no changes to the regional hazards or level of risks. Staff asked for all feedback and mitigation strategy ideas to be shared with staff prior to Tuesday, September 30th.

Resources and Gaps Working Group

Staff shared the Regional Resources and Gaps working group will resume meeting this fiscal year to develop project ideas. From these meetings, staff will begin the project process (i.e., surveys, RFQs, etc.) in case the 30% reduction is reinstated.

VTTX Opportunities

Staff shared there are plans to provide 3 virtual tabletop exercise series, with two offerings each, this fiscal year. The topics will include extended downtime, supply chain, and tropical weather. Registration and flyers will be shared as they become available.

Shelter-In-Place Training & Exercise

Later this fall and in early winter there will be shelter-in-place training and subsequent exercise opportunities in conjunction with the LEPC. More information to come.

OPEN DISCUSSION

- Hospitals Mr. Dave Chapman shared they continue to prepare for storm season. Mr.
 Chapman also shared the next FCDC meeting is being held virtually on Thursday, September 25th at 10am.
- Public Health –

Ms. Katie Jones (Duval County) shared they concluded their hurricane training if an activation is needed.

Mr. Philip Hernandez (St. Johns County) shared they completed their special needs shelter training for staff.

Mr. Sonny Rodgers (Clay County) shared they finished their back-to-school immunization drive, and on the last day of the drive they had their first case of measles in the county. Reports they are exercising their WIC COOP to Keystone Heights and continue to conduct quarterly ALF visits in conjunction with the hospitals. Shared BPR active assailant/threat and workplace violence working group training, and the dates of Florida Week at CDP in Anniston, AL – March 15-21, 2026.

Ms. Jaffy Lee (Flagler County) shared they continue hurricane season preparations, along with triage and discharge training with leadership.

Ms. Briana Angstman (Nassau County) shared they continue hurricane season preparations and collaborating with their ESF-8 partner contacts. Shared there were COVID-19 outbreaks in facilities.

- EMS Mr. Tim Devin shared there was nothing to report for EMS.
- Emergency Management Mr. Tim Devin (Clay County) encouraged healthcare facilities to reach out to their local emergency management agencies as there are new FEMA flood zone maps that may impact their facilities. Maps to take effect in 2027.




